Scope of RPZ Valve Tester

Members of the RPZ Valve Tester sector are only approved for operations and tasks associated with the commissioning and compliance testing of RPZ valves. The purpose is to verify conformity with the AIM and the Regulations through reporting observations, test results and failures when they occur.

Individual approved RPZ Valve Testers are **NOT** Approved Contractors as defined in the Regulations.

In regards, to notification or other work associated with installing or replacing RPZ valves, these activities are outside the scope of the RPZ Valve Tester sector. When installing or replacing RPZ valves every installer must meet the requirements as set out in the AIM and the Regulations.

Where installers are separately approved as an Approved Contractor, they must meet their scheme's requirements.
